DUI Levels of Care

- **Minimal Risk (Level 1):** Successful completion of a minimum of 10 hours of DUI Risk Education
- **Moderate Risk (Level 2):** 10 hours of DUI Risk Education. A minimum of 12 hours of early intervention provided over a minimum of four weeks with no more than three hours per day in any seven consecutive days.
- **Significant Risk (Level 3):** Successful completion of a minimum of 10 hours of DUI Risk Education. A minimum of 20 hours of substance abuse treatment. Subsequent completion of any and all necessary treatment. After discharge the DUI offender shall participate in all activities specified in the continuing care plan.
- **High Risk: (Level 4):** Successful completion of a minimum of 75 hours of substance abuse treatment. Subsequent completion of any and all necessary treatment. After discharge the DUI offender shall participate in all activities specified in the continuing care plan
